 - Seeks to serve youth in the community by bringing together academic, civic, social, family, and spiritual resources. While instilling a sense of greatness in them to help in their preparation to become independent adults.

 - Promoting more opportunities for positive interactions between community members and police officers by allowing each group to gain more knowledge and understanding. And creating a place for community to better understand police procedures.
